### Election Statement Release # 4, 21:00 AM

The International Society for Fair Elections and Democracy (ISFED) continues to monitor the 30 May 2010 local elections and parliamentary by-elections. The organization is monitoring the vote through 1,100 observers in electoral precincts, 73 observers at the district electoral commissions, 73 mobile groups and 15 groups of lawyers. At the same time, the organization is conducting qualitative and quantitative election-day monitoring. Through this press release, ISFED is presenting the data available by 21:00.

### ISFED quantitative monitoring results

By 12:00 the voter turnout was:

Turnout National: 20.1% with average votes per minute per precinct = 0.82

Turnout Tbilisi: 18.6% with average votes per minute = 1.01

By 17:00 the voter turnout was:

Turnout National: 40% with average votes per minute per precinct = 0.65

Turnout Tbilisi: 38.5% with average votes per minute = 0.86

International Society for Fair Elections and Democracy is continuing the monitoring and will present the findings to the public.
