

ISFED Statement # 2

Adjara Autonomous Republic Supreme Council Elections

79 Batumi Election District

On # 34 election precinct of # 79 Batumi Election District ex prisoner participated in voting process without presenting ID card, he only presented notification that he was free.

On # 55 election precinct of # 79 Batumi Election District the fact of voting instead of other was observed.

The same fact was observed on # 69 election precinct of # 79 Batumi Election District, based on false ID card. More precisely, citizen presented ID card of somebody Irakli Ormotsadze issues on May 15, 2005 and correspondingly he participated in elections. After some time, citizen Irakli Ormotsadze himself came to the election precinct, presented his own ID card, but someone had already voted instead of him. The complaint was submitted on this election precinct by ISFED observer.

As where is a doubt of participating in election by false ID cards, ISFED calls the procurator of Batumi, to investigate above mentioned fact and make according response.

On # 15 election precinct of # 79 Batumi election district, the fact of signing instead of other in voters' list was observed. The complaint was submitted by ISFED.

On # 75 election precinct of # 79 Batumi Election District the fact of voting by photocopy of ID card was observed. The complaint was submitted by ISFED observer.

On # 43 election precinct of # 79 Batumi Election District where was no mark in the voters' list, that voter was removed in mobile ballot box list. The same facts were observed in # 49 and # 52 election precincts. The complaints were submitted in all abovementioned election precincts by ISFED observers.

On # 68 election precinct of # 79 Batumi Election District the voter was not include in unified voters' list, but he was in mobile ballot box list.

On # 49 election precinct of # 79 Batumi Election District, commission members who were obliged to take mobile ballot box, were given just majoritarian bulletins, when they had to be

given both, majoritarian and proportional as well. The complaint was submitted by ISFED observer.

On # 51 election precinct of # 79 Batumi Election District ISFED observer was restricted the right to observe voting process wholly. On # 9 election precinct of the same election district, ISFED mobile group was restricted the full observation opportunity.

80 Keda Election District

On # 31 election precinct of # 80 Keda Election District the fact of voting without ID card was observed. The complaint was submitted by ISFED observer.

81 Kobuleti Election District

On # 46 election precinct of # 81 Kobuleti Election District the fact of voting without ID card was observed. The complaint was submitted concerning this fact, but precinct election commission did not registered ISFED's complaint. Correspondingly, ISFED submitted abovementioned complaint in # 81 Kobuleti District Election Commission.

On # 61 election precinct of # 81 Kobuleti Election District the fact of voting without ID card was observed. The complaint was submitted by ISFED observer.

On # 26 election precinct of # 81 Kobuleti Election District citizen, who was not included in unified voters' list, participated in voting process. The complaint was submitted on this election precinct.

82 Shuakhevi Election District

On # 3 election precinct of # 81 Kobuleti Election District the fact of voting without ID card was observed.

83 Khelvachauri Election District

On # 59 election precinct of # 83 Khelvachauri Election District the fact of ballot staffing (15 false bulletins) was observed. The complaint was submitted concerning the abovementioned fact by ISFED observer.

On # 38 election precinct of # 83 Khelvachauri Election District two voters voted without signing in voters' list. The complaint was submitted by ISFED observer.

On # 3 election precinct of # 83 Khelvachauri Election District the fact of pressure was observed on ISFED observer. Somebody called to ISFED observer and requested silence from her.

84 Khulo Election District

On # 17 election precinct of # 82 Khulo Election District the fact of voting (three voters) without marking process was observed. The complaint was submitted by ISFED observer.

For this time ISFED lodged 26 complaints in total to the Election Administrations (in Adjara A/R territory). From these, three complaints were not registered in precinct election commission and correspondingly, they are submitted to the relevant district election commissions.
