



ISFED Statement # 3

ISFED represents the results of the monitoring according to the information for 22:00 in the Adjara Region.

79 Batumi Election District

On election precinct # 20 of # 79 Batumi Election District fact of voting instead of other was observed.

On election precinct # 17 of # 79 Batumi Election District in the unified voters' list there was no mark that voters are removed in mobile ballot box list. The complaint was lodged by ISFED observer.

The same fact was observed in # 68 election precinct of # 79 Batumi election district. The complaint was lodged by ISFED observer and the result of mobile ballot box was annulled.

On election precinct # 43 of # 79 Batumi Election District was observed the fact, when voters who had already passed marking process tried to vote again. (15-20 voters).

On election precinct # 49 of # 79 Batumi Election District fact of voting instead of other was observed. The voter found out that someone had already signed in his signature. The complaint was lodged on this election precinct.

The same fact was observed on # 55 election precinct of # 79 Batumi election district, where was lodged complaint as well.

On election precinct # 55 of # 79 Batumi Election District 5 voters included in the mobile ballot box list weren't included in the unified voter's list. The complaint was lodged by ISFED observer.

On election precinct # 3 of # 79 Batumi Election District there was no registration stamp numbers on demonstration protocol. After ISFED observers request this technical gap was corrected.

On # 24 election precinct of # 79 Batumi Election District 5 citizens tried to vote using false ID cards. The same facts were observed on # 3 and # 25 election precincts of # 79 Batumi Election District.

On # 17 election precinct of # 79 Batumi Election District effort of voting without ID cards was observed.

On # 17 election precinct of # 79 Batumi Election District was observed pressure on ISFED observer.

81 Kobuleti Election District

On election precinct # **58** of # **81 Kobuleti** Election District there was a note in unified voters' list that voter is moved in mobile ballot box list, but this voter was not included in mobile ballot box list. The complaint was lodged by ISFED observer.

On election precinct # **15** of # **81 Kobuleti** Election District ballot was placed in ballot box without potting it in special envelope. The complaint was lodged by ISFED observer.

On election precinct # **29** of # **81 Kobuleti** Election District commission members gave election ballot to the citizen without requesting ID card. The complaint was lodged by ISFED observer concerning the mentioned fact.

82 Shuakhevi Election District

On # **38** election precinct of # **82 Shuakhevi** Election District was observed the fact of effort of voting using expire ID card.

On # **43 Akhaldaba** election precinct of # **82 Shuakhevi** Election District were observed unauthorized persons. Our observer was not given chance to lodge complaint, she was insulted and after the pressure was forced to leave the election precinct. Additionally, on mentioned election precinct was observed 175 voters turnout according to ISFED observer and 315 voters' turnout according to election precinct data.

On # **43** election precinct of # **82 Shuakhevi** Election District was observed the fact of ballot stuffing.

83 Khelvachauri Election District

On # **35** election precinct of # **83 Khelvachauri** Election District two not full aged citizens participated on elections and voted. Correspondingly, the complaint was lodged by ISFED observer.

On # **9** election precinct of # **83 Khelvachauri** Election District the fact of voting instead of other was observed. The complaint was lodged by ISFED observer.

On # **37** election precinct of # **83 Khelvachauri** Election District was observed the fact when in one election envelope was included more than one ballot, and this envelope was put in ballot box. Despite the fact, that ISFED observer tried to recheck the fact, she was not given this chance. Correspondingly, the complaint was lodged by ISFED observer.



On # 37 election precinct of # 83 **Khelvachauri** Election District the fact of bribery of ISFED observer was observed. ISFED observer was offered the job, in exchange for silence.

On # 37 election precinct of # 83 **Khelvachauri** Election District 5 false ballots were stuffed in the ballot box, by election commission member (appointed by the Unified National Movement). The complaint was lodged by ISFED observer.

On # 37 election precinct of # 83 **Khelvachauri** Election District by the mobile ballot box voted one additional voter. The complaint was lodge concerning this fact and as a result mobile ballot box results were annulled.

On # 11 election precinct of # 83 **Khelvachauri** Election District in the list of mobile ballot box was fixed 65 voters, but when box was returned it was revealed, that by mobile ballot box voted 70 voters. The complaint was lodged by ISFED observer and the results of this ballot box were annulled.

84 Khulo Election District

On # 26 election precinct of # 84 **Khulo** Election the fact of twice voting by the same person was observed. The complaint was lodged by ISFED observer on this election precinct.

On # 26 election precinct of # 84 **Khulo** Election ISFED observer was restricted the full observation right. Herewith, after Election District's intervene the abovementioned problem was set.

For this time ISFED lodged 41 complaints to the Election Administrations (in Adjara A/R territory).
